Jason Bridges, CPA, LLC individual tax preparation pricing is based on the National Society of Accountants annual survey of over 8,000 preparers nationwide. The average price for a tax return in 2018 (for the fiscal year 2017) was \$294.

It is important to understand that every tax return is different. The forms necessary to complete your tax return may vary from year to year as your situation changes. For that reason, final pricing is always subject to a client's individual situation and the complexity of their return. Normal hourly rates are \$125/hour. The minimum fee for tax preparation is \$200.
